AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

IMPORTANT - TRAINSEERS of dogs from regular classes to Best of Breed/Variety Competition (Ch. 11 Section 6, AKC Rules) MUST be made to the Superintendent/Show Secretary at least one half hour prior to the start of any regular conformation judging at this show.

Ramps can be used in emergency situations to judge any breed. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.
 For the judging of Juniors the ramp may be used at the discretion of the judge for the ramp optional breeds.

NO PRACTICING ALLOWED IN RINGS AT ANY TIME.

Dogs May Arrive any time prior to their scheduled time of judging. **Dogs not required for further judging will be excused.**

Judges Will Not Wait for Any Dog Holding Up a Class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

All Dogs Present must be held on leash or confined to their crates except when being judged or when in the exercising ring.

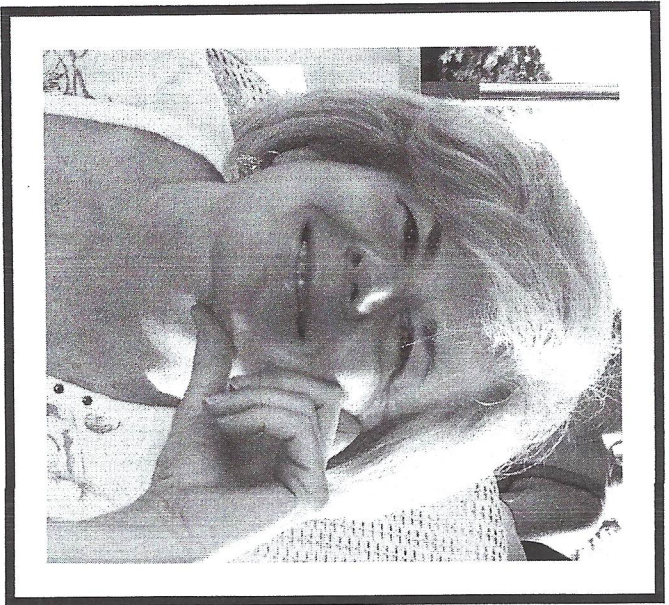
No gasoline or diesel generators are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

As specified in Chapter 12, Section 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

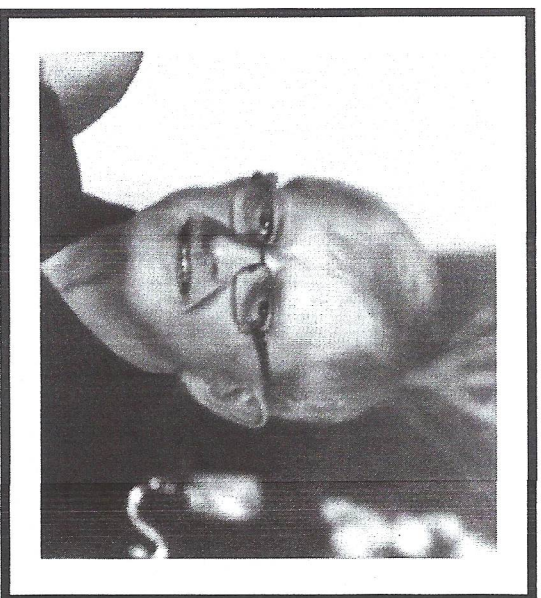


Regular Judge

I started in dogs with Poodles in 1961 at 11. Got my first Afghan in 1975. She was a combination of Holly Hill and Coastwind Gazebo. My first CH was CH Ajax of Troy out of Coastwind Abraxas. Went to #7 in Breed & Group ratings. From there I had dogs that were combinations of Akaba, Coastwind and Dynasty. Took a break to do children, soccer, baseball, and all the things dads needs to do with their boys. Then I acquired CH Tifarah Arcana Sister Act (CH Palhavi Rhythm of the Night x CH Kulana's Victory Express), one of the Top Producing Bitches of All Time 21 Champions, including All-Breed Best in Show Champions, Specialty Best in Show Champions, National Specialty Winners Bitch and Winners Dogs, Breeders Cup Winner, Top Winning Dog All-Breed in Japan with one of her daughters also being Top Producer at AHCA.

Schedule of Points

As of May 15, 2019

For complete Conformation Championship requirements see Chapter 16 of the Rules Applying to Dog Shows

The Points toward a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of both sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that completed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its own sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that completed in the regular classes for its sex in calculating championship points.

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater. If no points are available for the Best of Winners, the number of regular class dogs in both sexes are added together and compared to the point schedule. If the total sum of regular class dogs and bitches meets or exceeds the number of competitors needed for one point in its sex, the Best of Winners will receive one championship point.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.

NOTICE: An agent is a person 18 years or older, other than an owner or co-owner, designated by the owner or co-owner of an exhibit to be handler of, and responsible for, the dog at the show. Agent's names may be followed by the initials which represent their AKC-recognized professional group affiliation or certification. Persons seeking the services of such an agent should familiarize themselves with the requirements for professional group membership or certifications which are available at the superintendent's office.

HOW TO FIGURE POINTS IF YOUR CHAMPION DOG OR BITCH GOES BEST OF BREED

Grand Championship (GCH) points for BOB/Variety will be calculated according to the number of eligible dogs of both sexes competing in the regular and non-regular (eligible for Best of Breed/Variety) classes, as well as those dogs competing in Best of Breed competition. In no case shall BOB receive fewer GCH points than BOS.

A dog awarded BOS will be credited with eligible dogs of that sex competing in the regular and non-regular classes, as well as those dogs of that sex competing in BOB. A dog awarded Select Dog or Select Bitch will be credited with all eligible dogs of that sex defeated in the regular and non-regular classes, as well as those dogs of that sex defeated in BOB (Less the dog awarded Best of Breed/Variety or Best of Opposite Sex).

GCH points may only be awarded to Champions or unconfirmed Champions that are entered in BOB or winners of non-regular classes that are competing in BOB. TIPS: Non-regular class dogs that are not eligible for Best of Breed/Variety are not counted in determining points. Veteran dogs or any other eligible entrants from non-regular classes can earn Grand Championship points. Any Champion dog from the regular or non-regular classes is not considered for the requirement to defeat at least one Champion of Record at three shows.

TIPS: When counting dogs in competition, you only count dogs present that are judged. Dogs that are disqualified, dismissed, excused, absentee or have all awards withheld do not count.

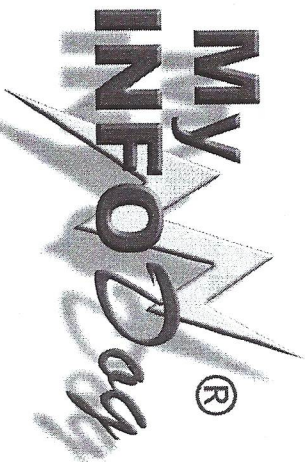
